

Shop safely online. Online shopping is easy, convenient — and the leading source of pandemic-related FTC fraud complaints. The Department of Homeland Security recommends that consumers transact business only with reputable vendors and make sure website data is encrypted. To learn more, visit http://us-cert.cisa.gov.

Surf with caution. Be wary of clicking links in emails, even when messages appear to be from loved ones or trusted sources. Clicking on these links may install malicious software on your computer or mobile device. Similarly, be alert to the threat of spoof websites, which look authentic but are actually fake pages trying to harvest your login credentials or other information.

Protect your debit card. Card Controls are now available on CU OnLine and TruGrocer's Mobile App to safeguard your TruGrocer debit card. You set your card as "active" only when you want to do transactions. You set declines, text alerts and email notifications based on your needs. Logon to CU OnLine> Additional Services>Card Controls or logon to the TruGrocer Mobile App and select "Card Controls" from the main menu to add these protections.
